Article 2. Tuition fees

- Tuition fees include:

*The Regional tax for the Right to University Education and the insurance premium may change due to new rules adopted by Edisu Piemonte and to the stipulation of a new insurance contract.

Article 3. Enrolment workload

- You class as enrolled for the academic year only after you pay the first instalment of your tuition fees (for payment schemes with two instalments) or after you pay your full tuition fees (for lump-sum payment schemes) and you complete the online enrolment procedure. After completing the enrolment procedure you receive a confirmation e-mail on your institutional account. There are different options for tuition fee payment depending on your enrolment workload, as stated in the following table:

For the sole purpose of calculating the number of years of enrolment, in this Tuition Fee Guide one year of part-time enrolment is worth 0.5 points (e.g. 4 full-time enrolments + 2 part-time enrolments = 5 enrolments; 4 full-time enrolments + 1 part-time enrolment = 4.5 enrolments, which are counted as 4 enrolments)

Article 5. Tuition fees for Bachelor's first-year students (first-time enrolment in a Bachelor's degree programme)

1. If you are under conditional enrolment for a.y. 2019/2020 (i.e., if you have not earned your high school diploma yet or you are currently enrolled at another university), you have to pay € 200.00 as first instalment of the comprehensive fee.
This amount will not be refunded if your conditional status is not lifted and you do not confirm your enrolment at Politecnico.
2. If you pass the TIL-I admission test and you enrol for the first time in a Bachelor's degree programme at Politecnico di Torino by 28th August 2019, you will get a € 70.00 reduction off the comprehensive fee (except for candidates who are exempted from taking the TIL test)
3. Both part-time and full-time students are entitled to get this reduction.

Article 6. Tuition fees for students approaching the end of their university studies

1. If you are a student enrolled in a Master's degree programme (belonging to the system pre-dating Ministerial Decrees No. 509/1999 and No. 270/2004) and you finished all your exams by September 2019 and you have already included the credits for the final examination (thesis credits) in your Annual Personal Study Plan of previous academic years, you can choose a full-time or a part-time workload. In both cases, you will have to pay € 359.51 as fixed fee amount.
2. You can apply for tuition fee reduction by submitting your ISEE/ISSEU declaration issued by INPS regardless of your enrolment workload (see following sections for further information). In this case, you will be charged the most favourable tuition fee amount between the fixed fee and the tuition fee calculated on your contribution level.

- ~~2. You must apply for tuition fee reduction before registering for the Bachelor's Final Examination and before the deadlines referred to in Section 3. You will not be able to apply for tuition fee reduction after enrolling in your Master's degree programme.~~

If you enrol in your Bachelor's degree programme over the fifth time in a.y. 2019/2020 and after graduation you enrol in a Master's degree programme during the same academic year, the extra charge (15/25%) applied to the second instalment of your tuition fees (in accordance with Article 57 Table 6) will be refunded to you after you enrol in your Master's degree programme.~~

If you meet the requirements referred to in Section 2 after you enrol in your Master's degree programme, your tuition fees are calculated as follows: (comprehensive fee due for your Bachelor's degree programme / 2) + (comprehensive fee due for your Master's degree programme / 2) + extra-Poli fees. The difference (if any) will be paid before the deadline for the second instalment (30th March 2020).~~

Article 7. (REPLACE THE FORMER) Tuition fees for students enrolling in a Bachelor's degree programme and in a Master's degree programme during the same academic year (2019/2020)

1. If you enrol in a Bachelor's degree programme in a.y. 2019/2020 and, after graduation, you enrol in a Master's degree programme in the same academic year, you can choose between a full-time or part-time enrolment workload.
Please note that your Master's enrolment workload (full-time or part-time) must be the same as your Bachelor's enrolment workload. Since part-time workload cannot exceed the maximum amount of 40

credits, the student who wants to exceed this limit has to request the change of his/her APSP from part-time to full-time to the Registrar's office before enrolling in the Master's degree programme. Any difference regarding the contribution due must be paid before 15th July 2020.

- You must apply for tuition fee reduction before registering for the Bachelor's Final Examination and before the deadlines referred to in Section 3. You will not be able to apply for tuition fee reduction after enrolling in your Master's degree programme.
- If you enrol in your Bachelor's degree programme over the fifth time in a.y. 2019/2020 and after graduation you enrol in a Master's degree programme during the same academic year, the extra charge (15/25%) applied to the second instalment of your tuition fees (in accordance with Article 57 Table 6) will be refunded to you after you enrol in your Master's degree programme.
- If you meet the requirements referred to in Section 2 after you enrol in your Master's degree programme, your tuition fees are calculated as follows: (comprehensive fee due for your Bachelor's degree programme / 2) + (comprehensive fee due for your Master's degree programme / 2) + extra-Poli fees. The difference (if any) will be paid before the deadline for the second instalment (15th July 2020).

Article 8. Tuition fees for students transferring from another university and enrolling in a Master's degree programme in the second semester of a.y. 2019/2020

- If you enrol for the first time in a Master's degree programme at Politecnico di Torino in second semester, you can choose your enrolment workload (full-time or part-time).
- In both cases, you must pay the two instalments of your tuition fees. You must pay your first instalment upon enrolment according to the tables of Section 4 and you will be assigned the highest contribution level (level 75). You will be able to apply for tuition fee reduction as described in Section 3 of this Guide and you will pay the second instalment according to the deadlines referred to in Section 4 of this guide

Article 9. Tuition fees for students enrolling in single courses

- If you enrol in single courses, you must pay a fixed fee and a variable fee, depending on the number of academic credits (CFU) you want to purchase.
- The fixed fee is € 350.11 (including revenue stamp and insurance); the cost of every academic credit is € 16.00.
- If you have been admitted to a Master's degree programme and you need to make a double enrolment for a.y. 2019/2020 (i.e., you must first enrol in single courses in order to make up for your unfulfilled academic requirements, and then enrol in a Master's degree programme), the fixed fee paid for single course enrolment will be deducted from the tuition fees due for your Master's degree programme up to a maximum of € 334.11 (the € 16.00 revenue stamp cannot be deducted). The amount of the fixed fee will be transferred to your student's virtual account by the deadline for paying the second instalment. If you withdraw from studies before the deadline for second instalment, the fixed fee amount will not be higher than the comprehensive Poli fee you already paid. The fixed fee cannot be refunded if:

- a) You have a full tuition fee exemption;
 - b) You decide to enrol in a Master's degree programme other than the programme you had initially chosen (you were enrolled in single courses to make up for your unfulfilled academic requirements for admission to a certain Master's degree programme but eventually enrol in another Master's degree programme);
 - c) You already have a Master's degree.
4. Students with refugee status or subsidiary/humanitarian protection who enrol in single courses must pay their tuition fees in accordance with Article 16 of this Guide.

Article 10. Students revoking or renouncing their E.Di.S.U. benefits

1. If you revoke or renounce your EDISU student benefits, you must pay your tuition fees for the year of revocation or renunciation in accordance with your contribution level.
2. It is Politecnico's responsibility to inform you if you lose your tuition fee exemption. Politecnico will send an e-mail to your PoliTo mailbox (s<matricola>@studenti.polito.it). You are required to pay your outstanding debt within one month.
3. Politecnico can place or remove a hold on your academic progress upon request of E.Di.S.U. if you have any outstanding debt with this institution.

Article 11. Alta Scuola Politecnica (ASP) students

1. If you are participating in the ASP programme (Alta Scuola Politecnica), you do not have to pay your tuition fees for the entire duration of the programme (two academic years). You just have to pay the extra-Poli fees referred to in Article 2. If you lose your ASP student status, you must pay your tuition fees retroactively (i.e. for those years in which you had a full tuition fee exemption). In this case, your tuition fees will correspond to your current contribution level. If you had not applied for tuition fee reduction, you will be assigned the highest contribution level.
2. If you lose your ASP student status, you will receive an e-mail into your official Polito mailbox s<matricola>@studenti.polito.it) and you will have to pay your tuition fees within one month.
3. Given all the above, we suggest you to apply for tuition fee reduction in order to pay your tuition fees according to your correct contribution level.
4. If during the same academic year you enrol in a Bachelor's degree programme, and then you enrol in a Master's degree programme and achieve the ASP student status, you will be reimbursed for the second instalment of the tuition fees paid for your Bachelor's degree programme. This applies only if you attended your Bachelor's degree at Politecnico.

Article 12. Students of the Young Talent Project (Percorso per i Giovani Talenti)

1. If you are a student of the Young Talent Project, you do not have to pay the comprehensive Poli fee. You will still have to pay € 159.53 (corresponding to the Regional tax for the Right to University Education, the Enrolment revenue stamp and the Premium for accident insurance).
2. If you lose the status of Young Talent Project student, you must pay your tuition fees for a.y. 2019/2020 according to your contribution level. If you had not applied for tuition fee reduction, you will have to pay the maximum fee amount.
3. If you lose the status of Young Talent Project student, you will receive an e-mail into your official Polito mailbox s<matricola>@studenti.polito.it) and you will have to pay your tuition fees within one month.
4. We suggest you apply for tuition fee reduction in order to pay the your tuition fees according to your correct contribution level.

Article 13. Students enrolling in first year of a Bachelor's degree programme partially taught in English (first year in English) or entirely taught in English

1. You can be exempted from paying your first-year tuition fees (except for the fees referred to in article 16) if you:
 - a) have a high school diploma awarded by an Italian high school;
 - b) enrol in first year of a Bachelor's degree programme partially or entirely taught in English with a TIL (admission test) score as shown below:
 - for Bachelor's degree programmes of the Engineering area (except for Industrial Production Engineering): minimum TIL-I score: 60/100 You cannot get a full tuition fee exemption if you had been exempted from taking the TIL-I test in accordance with the

Call for applications for admissions to the Bachelor's degree programmes of the Engineering area.

- for the Architecture Bachelor's degree programme: you must place yourself in a decile rank of 5 or greater in the admission test;

- c) have a C1 level English language certificate. You can find the list of the certificates accepted by Politecnico at <https://didattica.polito.it/cla/en/certificates>.

If you are exempted from having an English language certificate, you are not entitled to the tuition fee exemption referred to in this article.

Article 14. Technical and Administrative Staff of the University

1. Within the framework of its staff training policy, Politecnico offers its Technical and Administrative Staff a comprehensive fee reduction (excluding extra-Poli fees) in accordance with the provisions of a specific university Call for applications.

Article 15. Teacher Card/Carta docente

1. Within the meaning of Law no. 107/2016 (*Buona Scuola*), if you have the "Electronic card for school teacher training" (Teacher Card/*Carta docente*) with a maximum value of € 500.00, you can use it to pay part of your tuition fees. In order to do this, you must open a ticket on your personal page of the Teaching Portal, select the "TUITION FEES" topic and send the QR code of your teacher card.

Article 16. Students with tuition fee exemption

1. Some students are exempted from paying their tuition fees, but still have to pay the extra-Poli fees, which Politecnico collects and transfers to other institutions, as indicated in Article 2. Due tuition fees are listed below:

Article 17. Students whose comprehensive fee is partially or entirely paid by third parties

1. Some students do not have to pay their comprehensive fee as this is partially or entirely paid by a third party. These students still have to pay the extra-Poli fee amounts referred to in Article 2. The fee amounts are the following:

Article 19. Tuition fee payment options

When you enrol for a new academic year or when you register for the Final Examination, you can choose your preferred payment method from your personal page of the *Teaching Portal – Online services – Tuition Fees and payments – Pay your tuition fees*:

1. **MAV (Modulo Avviso Pagamento / electronic deposit slip)**. At first you must generate your MAV (please note that you have the possibility to enter a different amount from the one automatically generated by the system). You can pay your MAV at any bank counter or through the online banking service of your bank. If you wish to pay at a bank counter, you must print your MAV and show it at the bank counter. If you pay through the online banking service of your bank, you must use the code generated by the system and you do not need to print the MAV. The MAV is a univocal code and can be used only for the credit amount generated at the moment. The MAV is valid until the payment is done. A bank commission of € 0.59 is charged for any MAV transaction. The payment is automatically recorded within five days of the date of payment (after the bank has sent Politecnico the information). Therefore you do not need to go to the Office of the University Registrar in order to record your payment.

For any other operation requiring a simultaneous payment (for instance, first enrolment/enrolment for a new academic year, Final Examination registration) you must declare the date of payment: log in to the enrolment/registration procedure again and click the *Register MAV* button.

Please note that if you pay your MAV after 5.00 p.m., the bank might not record your payment on the same day (you must verify with your bank their recording schedule). This could be a problem if you pay on the deadline date (late penalties fees might be applied for late payment).

2. **Credit card (Visa or MasterCard) or debit card**; a 1% bank commission is charged. At the end of the procedure you will get a payment receipt with all the details.

3. **PagoPA** (online electronic payment to the Public Administration): it is an electronic payment system which allows users of online banking services to choose a bank or a payment institution (defined as “Payment Service Provider” – PSP) among those recognized at national level.

For any other operation requiring a simultaneous payment (for instance, first enrolment/enrolment for a new academic year, Final Examination registration) you must declare the date of payment: log in to the enrolment/registration procedure again and click the *Register MAV* button.

You can also pay at the front office of the Office of the University Registrar/ Offices of Student Services, by:

2. **Bank debit card (Bancomat)**;

3. **Credit card (Visa or MasterCard)**: a 1% bank commission of 1% is charged.

Article 20. Failure to pay or late payment of tuition fees – hold on your academic progress

Article 20. (REPLACE THE FORMER) Failure to pay or late payment of tuition fees – hold on your academic progress

If you do not pay your tuition fees by the deadline for second instalment, or if you pay less than the amount due, a hold will be placed on your academic progress and you will not be able to perform any further operations (exams, withdrawal from studies, etc.). The hold will be removed upon full payment of your outstanding debts. If you are placed on a hold, all your exam registrations are cancelled and you cannot register for any exam until your payment has been recorded.
7. The fee charged for removing the hold is € 10, if you pay within the first 15 days of the deadline. If your payment takes place after the 15th day, you will be charged an additional cost (10% of your debt).
8. The fee charged for removing the hold must be paid by 15th July 2020 (or before the registration deadline for the Final Examination, if this is earlier).
9. If you are placed on a hold, you will receive an e-mail into your PoliTo mailbox (s<matricola>@studenti.polito.it).
10. You will have to pay your outstanding debts even if you incur in automatic forfeiture (i.e., if you are considered to have forfeited and cannot continue your studies in the same academic path).

Article 21. Failure to pay or late payment of other debts –hold on your academic progress

Article 21. (REPLACE THE FORMER) Failure to pay or late payment of other debts –hold on your academic progress

4. All outstanding debts in your virtual account (for example: costs for a replacement smart card, IELTS registration fee...) must be settled by 15th July 2020 (or before the registration deadline for the Final Examination, if this is earlier). If you do not pay your outstanding debts, a hold will be placed on your academic progress and you will not be able to perform any further operations (exams, withdrawal from studies, etc.).The hold will be removed upon full payment of your outstanding debts. If you are placed on a hold, all your exam registrations are cancelled and you cannot register for an exam until your payment has been recorded.
5. If you are placed on a hold, you will receive an e-mail into your PoliTo mailbox (s<matricola>@studenti.polito.it).
6. You will have to pay your outstanding debts even if you incur in automatic forfeiture (i.e., if you are considered to have forfeited and cannot continue your studies in the same academic path).

Article 22. Students' virtual account

1. When you enrol at Politecnico, you establish a system of economic relations similar to a bank account with Politecnico. This economic relation system is called "student's virtual account". This means that when you pay something to Politecnico (i.e., when you pay the second instalment of your tuition fees, when you ask for a replacement smart card ...), you owe money to Politecnico; on the other hand, under other circumstances you can become a creditor of Politecnico (i.e., if you obtain tuition fee reimbursement for academic merit).
2. All debits and credits, as well as money transfers, are recorded into your virtual account. You can check it by logging in to your personal page of the Teaching Portal – *Segreteria on-line/Online services – Tuition fees and payments – Pay your tuition fees*.
3. Any money you transfer to your virtual account automatically first settles your outstanding debts. For instance, if you intend to pay the second instalment of your tuition fees and you transfer the corresponding amount of money into your student's virtual account but your account has a negative balance due to other outstanding debts with previous deadlines, the money you transferred will settle

these previous debts or part of these debts. This means that the second instalment of your tuition fees remains partially or totally unpaid. When the deadline for the second instalment expires, a hold will be placed on your-academic progress and you will be charged a late penalty fee in accordance with Article 20.

Article 23. How to claim a refund

1. If your virtual account has a credit balance, you can claim a refund following the online procedure available on your personal page of the Teaching Portal – Segreteria online – Tuition fees and payments – Pay your tuition fees. In any case, at the end of every academic year, Politecnico will refund all students who have graduated during the year and who are not continuing their studies at Politecnico, if their virtual account has a credit balance.
2. You can receive refunds from Politecnico only if you have chosen a payment method by entering this information on your personal page of the Teaching Portal – *Segreteria online – Tuition fees and payments*.
3. The options for reimbursement are the following:
 - a) Bank or Bancoposta transfer: you must be the holder or co-holder of a bank account and you must indicate its IBAN code in order to receive the refund.
 - b) Cash: as soon as money is available, you will receive an e-mail in your PoliTo mailbox with the instructions for collecting your refund. You must go to a UniCredit bank counter with your identity card and your fiscal code in order to get your money.
4. If your credit is € 1.000.00 or greater, money can be refunded by bank transfer only, in accordance with Article 12 of Decree-Law No. 201 of 6th December 2016.
5. If you do not enter your bank details correctly or if you do not withdraw your cash by the deadline, a new refund is not automatic and you need to make a new refund request.

Article 24. Other charges for individual services rendered upon request

1. Your university path involves some administrative operations that require to be paid.
2. The Student Guide describes these operations and their effects on your academic progress. This is a summary table of these charges.

Article 25. New enrolment– recognition of previously earned credits

1. The cost for the recognition of the credits you earned during your previous university path (after forfeiture, withdrawal from studies, enrolment in single courses, etc.) is composed of a fixed fee (€ 150.00) plus € 16.00 for each recognized credit.
2. You are required to pay this amount only if your previous university path took place in a university other than Politecnico.

Article 26. Transfer to a PoliTo Bachelor's degree programme - charge for unfinished procedure

1. If you are transferring to Politecnico from another university, you have to pay € 200.00. If your transfer is completed successfully, this amount will be deducted from your tuition fees; otherwise, if you eventually decide not to enrol at Politecnico, it will not be refunded.

Article 27. Transfer out (*congedo*)

1. If you apply for a transfer to another university (*congedo*) before the payment deadline for the second instalment of your tuition fees, you do not need to pay your second instalment.
2. If you have not been assigned your final contribution level for a.y. 2019/2020 by the time you apply for a transfer, you must pay the first instalment of your tuition fees based on the highest contribution level (see Article 43.1.b), unless you have applied for tuition fee reduction before your transfer application.
3. The fee charged for a transfer application is € 66.00 of which: € 50.00uro for administrative fees and € 16.00 for the revenue stamp.

Article 28. Credit Transfer (*abbreviazione carriera*) - charge for unfinished procedure

1. If you have a university degree and you apply for credit transfer, you must pay € 100.00 at the beginning of the credit transfer process. If you confirm your credit transfer, this amount will be deducted from your tuition fees; otherwise, if you eventually decide not to enrol at Politecnico, it will not be refunded.

Article 29. Interruption and resumption of studies

1. If you intend to resume your studies after one or more years of interruption, you will have to settle possible outstanding debts deriving from your last year of enrolment, plus a fixed fee (€ 100.00) for every year in which you have not been enrolled at Politecnico.
2. If you do not complete your enrolment for the new academic year, you will have to pay an administrative fee of € 100.00.
3. If you also need to get the evaluation of your previous academic records, you have to pay € 150.00. This amount will be deducted from your tuition fees if you enrol at Politecnico; otherwise, if you eventually decide not to enrol at Politecnico, it will not be refunded.

Article 30. Internal transfer – charge for unfinished procedure

1. If you apply for an internal transfer but you do not eventually confirm it, you will be charged a fee for the evaluation of your previous academic records (€ 50.00).

Article 31. Evaluation of previous academic records for admission to a Master's degree programme – charge for unfinished procedure

1. If you are transferring from another university and you intend to enrol in a Master's degree programme at Politecnico di Torino, you have to pay € 100.00 for the evaluation of your previous academic records. If you are admitted to Politecnico and you confirm your enrolment, this amount will be deducted from your tuition fees; otherwise, it will not be refunded.

Article 32. Tuition fee reduction based on academic merit

1. If you have a high academic performance (measured with the score described below), you class as high-achieving student. In this case, you can get a tuition fee reduction up to a maximum of € 300.00. This reduction is applied to your comprehensive fee (but not on the revenue stamp, regional tax and insurance – see Article 2)
2. If the first instalment of your tuition fees is reduced down to zero due to this merit-based reduction, you still have to pay the € 16.00 revenue stamp upon enrolment.
3. In order to calculate your merit score, Politecnico takes into account the exams you passed from 10th August 2018 to 10th August 2019. Exams taken during a closed university path, although already recognized by Politecnico (e.g., credit transfer exams) are not taken into consideration for this calculation.
4. The score is calculated as follows: a) multiply the number of credits of every exam passed at Politecnico in the above-mentioned period by its grade (please consider that pass-or-fail exams are assigned the weighted average grade of the other exams); b) add the results of these products.
5. To obtain a merit-based reduction, you need to get at least 1000 points if you are a first-year student in a.y. 2018/2019 or at least 1225 points if you are a continuing student (enrolled in year two or beyond).

6. You are entitled to obtain a merit-based reduction if you reached the above-mentioned score in a.y. 2018/2019, provided that you are enrolled at Politecnico as a full-time student for a.y. 2019/2020. Part-time students are not entitled to receive any merit-based tuition fee reduction. If you were a third year Bachelor's student in a.y. 2018/2019, you can get this merit-based reduction for a.y. 2019/2020 only if you enrol in a Master's degree programme during a.y. 2019/2020. In this case can get this reduction after enrolling in your Master's degree programme.
7. Any exams passed in order to make up for unfulfilled academic requirements do not count towards this score.
8. This procedure (calculation of your merit score and refund on your virtual account) is automatic. The calculation of your reduction is based on your final contribution level or, if this is still unavailable, on your provisional contribution level. When your final contribution level becomes available, possible adjustments are applied to the second instalment of your tuition fees, after 15th March 2020.
9. You can get a merit-based tuition fee reduction for no more than three times if you are enrolled in a Bachelor's degree programme (the third reduction is possible only if you have already enrolled in a Master's degree programme). Merit-based tuition fee reduction can be offered one time only to second-year Master's students.
10. You cannot earn any merit-based tuition fee reduction if:
 - a) you have a part-time enrolment workload;
 - b) you already earned a degree of the same level as the university path you are enrolling in (second Bachelor's degree or second Master's degree)
11. If you withdraw from studies before the deadline for paying your second instalment, your merit-based tuition fee reduction cannot be higher than the comprehensive fee you actually paid.

Article 33. Outgoing students: calculation of academic merit for the attribution of benefits referred to in Article 32 and 35

1. If you are an outgoing student participating in a mobility programme abroad or in a specific international educational path, some of the exams you took abroad may not be recorded by 10th August 2019. In this case Politecnico calculates your merit score for the attribution of the benefits referred to in Article 32 and 35 in accordance with the criteria mentioned in the next paragraphs. In any case, you can receive the above-mentioned student benefits only after you exams are recorded in your transcript.
2. If your mobility programme ends before 10th August 2019, your merit score is calculated on all validated exams.
3. If your mobility programme ends after 10th August 2019, your merit score is calculated proportionally to the credits you earned during your mobility programme.
 - a. The number of credits is calculated as follows: (total number of validated credits) / (total number of mobility days) * (number of days from the first mobility day to 10th August 2019)
 - b. For the calculation of the score for merit-based reduction (Article 32): credits calculated with the method illustrated under letter a) are assigned a grade corresponding to the average grade of all the exams taken during the mobility programme and recognized by Politecnico.

SECTION 2

Article 34. Tuition fees for students who meet the requirements of the 2017 Budget Law (Law no. 232 of 11th December 2016) integrated by the resolution of the Board of Directors of 27th February 2018

If you are enrolled in a Bachelor's or Master's degree programme and you meet **all** the requirements listed in the next articles (income, number of earned credits, number of years of enrolment), you can be exempted from paying your comprehensive fee, or, you pay the comprehensive fee amount established by the above-mentioned Budget Law and BoD resolution. In any case, you must pay the extra-Poli fees (regional tax, revenue stamp, insurance – these are called extra-Poli fees in the tables below). Your ISPE value (Indicatore della Situazione Patrimoniale Equivalente) is not relevant.

This payment scheme applies both to part-time and to full-time students (for part-time students Politecnico calculates the tuition fees according to the following Tables and Articles 4 and 6; the student will be charged the most favourable amount).

For the purposes of verifying if a student fulfils the requirements, one year of part-time enrolment is worth half year (0.5/year).

Article 35. Students enrolling in a Bachelor's degree programme or in a Master's degree programme

SECTION 3

Article 36. Tuition fee reduction

1. If you are enrolled in a Bachelor's degree programme or in a Master's degree programme, you can get a tuition fee reduction provided that you apply for it. You must submit your application for tuition fee reduction every academic year.
2. If you do not apply for tuition fee reduction, you must pay your tuition fees based on the highest contribution level (75).
3. You can apply for tuition fee reduction upon enrolment (see Article 42) or at a later stage. You must submit your application online from Segreteria online – Tuition fees and payments – Apply for tuition fee reduction – see Article 43. You need to have an ISEE declaration issued by INPS for “prestazioni per il diritto allo studio universitario” (services for the right to university education) in order to fill out your application.
4. If you are a non-EU citizen or an EU citizen with a family unit that does not generate income in Italy (or not totally in Italy), you must have the “Indicatore Sostitutivo dell'ISEE” (Substitute value for the ISEE indicator), called ISEE Parificato.
5. You can get a tuition fee reduction if your family's Equivalent Economic Situation Indicator (ISEE) does not exceed the limit of € 85.500,00 and if your family's Equivalent Property Situation Indicator (ISPE) does not exceed the limit of € 200.000,00.
6. These indicators have the following acronyms:

ISEE Universitario ISEEU ISEEUP		≤ 85.500,00 €
ISPE ISPEU ISPEUP	<i>This value is calculated by dividing the ISP (Property Situation Indicator) by the Equivalence Scale</i>	≤ 200.000,00 € *

* This indicator is not taken into account if you meet the requirements listed in section 2.

7. To apply for tuition fee reduction, you can use your ISEE Universitario based on a *Dichiarazione Sostitutiva Unica* (DSU) which must be valid at the date of your application.
8. To apply for tuition fee reduction, you can use your ISEE Parificato issued during the academic year for which you intend to request the reduction (see Articles 39.42.43.44).

Article 37. Students who are not eligible for tuition fee reduction

1. You cannot apply for tuition fee reduction if you:
 - a) are enrolled in single courses;
 - b) have a university degree and enrolls in a degree programme of the same level (e.g., if you have a Bachelor's degree and you want to enrol in a Bachelor's degree programme);
 - c) are a non-Italian student enrolled at Politecnico within the framework of an agreement between Politecnico and your university of origin;
 - d) are enrolled in a Specializing Master's programme (*Master Universitario*).

Article 38. ISEE Universitario

1. You can get your ISEE declaration from any authorized office (for instance, a CAF – *Centro di Assistenza Fiscale*/Centre for Fiscal Assistance) where you must ask for the **ISEE Universitario** (*ISEE per prestazioni agevolate per il diritto allo studio universitario*/ ISEE for special support services for the right to university education). You will have to fill out the DSU form and you will receive a copy of it. The authorized office will later send your DSU to INPS (*Istituto Nazionale di Previdenza Sociale*/ National Institute for Social Security) for the calculation of your ISEE. After you fill out your DSU form, you must apply for tuition fee reduction from your personal page of the Teaching Portal.
12. The ISEE declaration will be issued by INPS within 15 working days.

Article 39. ISEE Parificato (for non-Italian students)

1. If you are a non-EU citizen or an EU citizen with a family unit that does not generate income in Italy (or not totally in Italy), you must ask for the ISEE Parificato from a CAF (*Indicatore Sostitutivo dell'ISEE*/ Substitute value for the ISEE indicator).

EDISU Piemonte will identify the CAFs that can issue the ISEE Parificato in Piemonte. The list of these CAFs will be published at: https://didattica.polito.it/tasse_riduzioni/.

Article 40. Independent students (for ISEE purposes)

1. You class as independent student if you simultaneously meet the following two requirements:
 - a) you have been living in a different house from that of your family of origin for at least two years at the moment of your application submission and the house you have been living in does not belong to your family;
 - b) you have been generating and declaring an income above € 6.500,00 deriving from an employment contract or likewise, for at least two years.
2. If you live in a different house from that of your family of origin, but you do not meet either one or both the above-mentioned requirements, you do not class as an independent student. In this case, you must refer to the financial and patrimonial condition of your family of origin.
3. Independent students are required to send a ticket (select the "Tuition fees" topic) before they apply for tuition fee reduction in order to verify if they actually meet the requirements mentioned in paragraph 1.

Article 41. How to apply for tuition fee reduction

1. You can apply for tuition fee reduction ONLY online, upon enrolment (see Article 42) or at a later stage. You must follow the guided procedure available on your personal page of the Teaching Portal / *Portale della Didattica* (as explained in Article 43).
2. Your application for tuition fee reduction is valid throughout a.y. 2019/2020 and can be modified only if you provide your "ISEE Corrente".
3. Politecnico reserves itself the right to check the values of your ISEE Universitario/Parificato. Should any errors or inconsistencies be found, you will be informed by e-mail only. You will receive this message in your PoliTo mailbox (s<matricola>@studenti.polito.it).
4. If for any reason you cannot submit your application before the deadline, you are required to report your problem and send a ticket from your personal page (select the "Tuition fees" topic and the "ISEE declaration" subtopic).

Article 42. Applying for tuition fee reduction upon enrolment

1. You can apply for tuition fee reduction using your **ISEE Universitario**. The application can be submitted upon enrolment (when you first enrol at Politecnico or when you enrol for a new academic year). In this case, you will be asked to give your consent to allow Politecnico to query the INPS database to retrieve your data.
 - a. **If you give your consent and a valid ISEE Universitario is retrieved from the INPS database, you will be assigned your final contribution level.**
 - i. If you are a first-year student, you are required to pay € 200.00 for the first instalment of your tuition fees.
 - ii. If you are a continuing student, you are required to pay the first instalment of your tuition fees according to your final contribution level.
 - b. **If you give your consent but a valid ISEE Universitario is NOT retrieved from the INPS database, you will be assigned a provisional contribution level as follows:**
 - i. If you are a first-year student, you are provisionally assigned the highest contribution level and you are required to pay € 200.00 (first instalment).
 - ii. If you are a continuing student, you are provisionally assigned last year's contribution level and you are required to pay the first instalment of your tuition fees according to that provisional level.

The INPS database will be queried to retrieve your ISEE data until 20/12/2019 (or until 15/04/2020 for transfer students and for students who earned their Bachelor's degree at Politecnico up to a.y. 2018/2019 and enrol in a Master's degree programme in second semester):

- i. if a valid ISEE Universitario (issued before the above-mentioned deadline) is retrieved from the database, you will be assigned your final contribution level.

- ii. If no valid ISEE Universitario is retrieved, your provisional contribution level will be revoked before 16th January 2020 (you will receive an e-mail in your PoliTo mailbox: s<matricola>@studenti.polito.it). In this case, you can apply for tuition fee reduction in second semester following the instructions illustrated in Article 43.1 and according to the deadlines of Article 44.

If you are a continuing student applying for a transfer or for a withdrawal from studies but you have not been assigned your final contribution level for a.y. 2019/2020 by the time you submit your application, your first instalment will correspond to the highest contribution level. If you pay a lower amount but you are eventually assigned to a higher contribution level, you are required to pay the difference between the provisional level and the final level when you leave Politecnico.

c. **If you do NOT give your consent, you will be assigned the highest contribution level.**

- i. If you are a first-year student, you are required to pay € 200.00 for the first instalment of your tuition fees.
- ii. If you are a continuing student, you are required to pay the first instalment of your tuition fees according to the highest contribution level.

You can still apply for tuition fee reduction at a later stage in accordance with the instructions of Article 43.1 and the deadlines of Article 44. If you do not submit any application for tuition fee reduction, you will be irrevocably assigned the highest contribution level.

2. If you apply for tuition fee reduction using your **ISEE Parificato**, you have the following options:

- a. If you are a continuing student (enrolling in year 2 or beyond) you can apply for tuition fee reduction upon enrolment by confirming the economic data you declared in previous academic years.
 - i. **If you confirm your previous economic data**, your final contribution level will correspond to last year's level. You are required to pay the first instalment of your tuition fees accordingly.
 - ii. **If you do NOT confirm your previous economic data**, your contribution level will be the highest one and you will have to pay the first instalment of your tuition fees accordingly. You can still apply for tuition fee reduction at a later stage in accordance with the instructions of Article 43.2 and the deadlines of Article 44.
- b. If you are a first-year student (first-year enrolment in any degree programme) or if you are moving from Bachelor's level to Master's level, you are required to pay € 200.00 for the first instalment of your tuition fees. You can apply for tuition fee reduction at a later stage in accordance with the instructions of Article 43.2 and the deadlines of Article 44.

When you are assigned a contribution level (final or provisional), you will receive an e-mail into your PoliTo mailbox(s<matricola>@studenti.polito.it).

Article 43. Applying for tuition fee reduction after enrolment

If you do not give your consent to query the INPS database upon enrolment, you can still apply for tuition fee reduction after enrolment.

1. Applying for tuition fee reduction with ISEE Universitario

- a. Log in to your personal page of the Teaching Portal – *Online Services – Tuition fees and payments – Apply for tuition fee reduction (Portale della Didattica, - Segreteria on-line - Tasse e pagamenti - Richiesta di riduzione tasse)* - and follow the guided procedure:
 - i. *If your ISEE Universitario has already been calculated by INPS*
You must check that the data displayed on your personal page are correct and coincide with your ISEE. Then you must confirm you data to complete the process.
 - ii. *If your ISEE Universitario has not been calculated yet but you have a valid DSU*
You must enter the date of your DSU. You will be automatically assigned your contribution level when your ISEE is calculated by INPS.
- b. After submitting your application for tuition fee reduction, you will receive a confirmation e-mail into your PoliTo mailbox(s<matricola>@studenti.polito.it) with your final contribution level.

2. Applying for tuition fee reduction with ISEE Parificato

- a. Log in to your personal page of the *Teaching Portal – Segreteria online – Tuition fees and payments – Apply for tuition fee reduction (Portale della Didattica, - Segreteria on-line - Tasse e pagamenti - Richiesta di riduzione tasse)*.
- b. *Fill in the following fields:*
 - i. ISEEU/ ISEEUP value;
 - ii. ISPU/ISPUP value;
 - iii. Equivalence scale (enter two digits only);
 - iv. issue date.

The ISPEU/ISPEUP value is calculated automatically.
- c. Upload your ISEE Parificato in a single PDF file (all pages in one file). You cannot submit your online application without uploading this PDF file.
- d. After submitting your application, you will receive a confirmation e-mail into your PoliTo mailbox (s<matricola>@studenti.polito.it) with your final contribution level.

Article 44. Application deadlines for tuition fee reduction

Article 45. Verification of ISEE declarations with omissions/inconsistences

If you apply for tuition fee reduction (according to Articles 42 and 43 of this Guide) using an ISEE declaration with omissions/inconsistences (reported by INPS), your ISEE declaration will be provisionally accepted and you will be assigned the provisional corresponding level.

In this case, you will receive an e-mail message into your PoliTo mailbox and you will be required to provide one of the following documents within 30 days of the date of the e-mail message:

1. A new ISEE declaration without any omissions/inconsistences. This new ISEE declaration will substitute the previous declaration (provisionally accepted) and you will be assigned the corresponding contribution level. No sanctions will be imposed on you if your final contribution level is different from your provisional level.
Or,
2. Documents showing that your first ISEE declaration was actually correct and truthful.

If you do not submit the documents referred to in point 1 and 2 before the abovementioned deadline, you will be assigned the highest contribution level and you will not be able to apply again for tuition fee reduction for a.y. 2019/2020.

Article 46. Students applying for Edisu benefits

1. If you apply for an Edisu scholarship, you do not need to apply for tuition fee reduction (please note that Edisu benefits are regulated by Edisu rules).
2. Edisu scholarship applicants are assigned a contribution level that corresponds to the value of the ISEE Universitario/ISEE Parificato they presented to Edisu. Edisu automatically sends your data to Politecnico.
3. If you are awarded an Edisu scholarship or are eligible for it (*vincitore/idoneo*), you are exempted from paying your tuition fees (except for the revenue stamp and insurance – see Article 2).
4. Tuition fees for scholarship applicants vary according to the year of enrolment: the amount paid by Bachelor's or Master's first-year students is different from the amount paid by continuing students, as detailed below:

5. If you are a first-year student (i.e. you are enrolled in first year of a Bachelor's or Master's degree programme) you can claim a refund for the first instalment of your tuition fees (except for the revenue stamp and insurance – see Article 2) as soon as you meet the requirements listed in the Edisu Call for applications.
6. If last year you were a scholarship recipient or you were eligible for a scholarship (*vincitore/idoneo*), upon enrolment you must declare if you intend to apply again for an Edisu scholarship for this academic year.

- a. If you declare that you want to apply for a scholarship for this academic year, you will provisionally class as eligible for the scholarship. The confirmation of your effective eligibility will come only after the publication of the Edisu ranking list and the transfer of your data from Edisu to Politecnico.
- b. If you declare that you did not apply nor you are going to apply for a scholarship for this academic year, you can apply for tuition fee reduction in accordance with Article 42-43 and the deadlines of Article 44.

Article 47. Bachelor's students with over 7 enrolments / Master's or Laurea Specialistica students with over 5 enrolments / Students enrolling in Bachelor's degree programmes belonging to the system pre- dating DM 509/99 or Diploma Universitario

1. If you enrol as a full-time student in a Bachelor's degree programme for a.y. 2019/2020 over the 7th time, or, if you enrol in a Master's degree programme (or *Laurea Specialistica*) over the 5th time, or if you enrol in a Bachelor's degree programme or *Diploma Universitario* belonging to the system pre-dating DM 509/99, you can apply for tuition fee reduction according to the deadlines and modalities of Section 3.
2. If your ISEE Universitario is above € 150,000.00 you will be assigned the highest contribution level (75). In this case your tuition fees amount to € 3.815,24 (see Tables of Section 4).

Article 48. Automatic assignment to the highest contribution level after inspections

1. If Politecnico inspections find out that you entered inconsistent or unreal data in your application, or if you failed to attach your full ISEE Parificato (when requested), you will receive an e-mail message into your PoliTo mailbox.
2. In this case, you must provide the necessary documents before the deadlines indicated in the e-mail.
3. If you fail to submit these documents before the deadlines, you will be automatically assigned the highest contribution level (level 75).
4. The decision to assign a student the highest contribution level is irrevocable.

Article 49. Self-certificate verifications

1. The ISEE Universitario/Parificato declaration used for your application for tuition fee reduction is a regular self-certificate and requires you to be fully accountable for the truthfulness of your declarations (Presidential Decree No. 445 of 28th December 2000). Within the meaning of article 76 of this decree, if you make false declarations, produce or use untrue data, you are punished in accordance with the penal code and other special provisions.
2. The self-certificate could be subject to an annual sample inspection conducted by Politecnico.
3. For this purpose, Politecnico is entitled to ask you to provide any necessary information and is allowed to conduct investigations with the competent administration offices. At the end of these investigations, should it result that either your declaration or documents are false, you will be revoked all benefits and you will have to refund the money; moreover, the situation could be reported to the court.
4. Once the verification process has begun, it cannot be stopped (even if, for example, you spontaneously renounce your undue benefits).
5. If you are selected for an inspection, you will receive an e-mail message into your PoliTo mailbox. The result of this verification and any decisions taken in case of irregularities will be communicated by e-mail as well.
6. These decisions are not open to appeal within Politecnico.

Article 50. Disciplinary sanctions

1. If you make false, incomplete or inconsistent declarations, you will be subject to penalties in accordance with paragraph 3 of article 10 of Legislative decree No. 68 (29th march 2012). You will also be subject to disciplinary sanctions imposed by the university up to temporary exclusion from Politecnico.

Article 51. Processing of personal data

1. In accordance with the General Data Protection Regulation (EU Regulation 2016/679) and the Code regarding the protection of personal data (Legislative Decree No. 196 of 30th June 2003 and further amendments), Politecnico di Torino will process your personal data in pursuit of its institutional aims

and in accordance with the transparency purposes imposed by the law. The processing of personal data is based on the principles of correctness, lawfulness and relevance of purposes.

Article 52. Information and participation in administrative proceedings

Article 53. Final provisions

1. In accordance with the Student Regulations, on instances concerning your academic progress appeals may be raised to the Rector, who in response may avail himself of a purposely appointed Commission.
In the event of changes in the procedures or terms of this Guide (exclusively for technical and operational reasons) or changes in the tuition fee amounts due to external events (such as new revenue stamp costs imposed by the law after this Guide is published), the person in charge is the Head of the Division of Student Affairs.

The registration fee to take the IELTS exam organized by the CLA in cooperation with IDP Education Canada Lt is € 153.00 until 31/12/2019. Politecnico will publish updated rules and costs for sessions scheduled after 1st January 2020.

1. You can take the IELTS exam at the CLA one time free of charge if:

a) you are enrolled in a **Bachelor's degree programme** (DM 270/04 or 509/99) at Politecnico di Torino and the **English language exam is one of your curricular requirements**;
b) you are enrolled in a **Laurea Specialistica** (DM 509/99) at Politecnico di Torino and the **English language exam is one of your curricular requirements**, provided that you have not already taken the IELTS exam free of charge one time and you have not received any IELTS fee refund during previous university paths.

2. You **cannot** take the IELTS exam at the CLA free of charge if:

- a) you are enrolled in a **Master's degree programme** (DM 270/04) at Politecnico di Torino;
- b) you already earned the English language exam credits because you presented an English language certificate to Politecnico di Torino.

The following rules apply if you have the right to take the exam free of charge.

3. If you register for the IELTS exam, but you do not take all the exam modules:

- a. if you cancel registration for the IELTS exam before the deadline of the Terms and Conditions (accepted during the registration process), you will not be charged the IELTS fee and you will be able to register again for a new exam session free of charge.
- b. if you justify your absence with the necessary documents before the deadline of the Terms and Conditions (accepted during the registration process), you will not be charged the IELTS fee and you will be able to register again for a new exam session free of charge.
- c. if you do not cancel your registration for the IELTS exam or if you do not justify your absence in accordance with the Terms and Conditions (accepted during the registration process), you will be charged the IELTS fee in full, but you will be able to register again for a new exam session free of charge.

The following rules apply if you do not have the right to take the exam free of charge.

4. If you register for the IELTS exam but you do not take all the exam modules:

- a. if you cancel your registration for the IELTS exam before the deadline of the Terms and Conditions (accepted during the registration process), the IELTS fee will be refunded to you.
- b. if you justify your absence with the necessary documents before the deadline of the Terms and Conditions (accepted during the registration process), the IELTS fee will be refunded to you.
- c. if you do not cancel your registration for the IELTS exam or if you do not justify your absence with the necessary documents before the deadline of the Terms and Conditions (accepted during the registration process), the IELTS fee will not be refunded to you.

Article 58 (REPLACE THE FORMER) IELTS (English language exam) payment policy

The registration fee to take the IELTS exam organized by the CLA in cooperation with IDP Education Canada Lt is € 153.00 until 30/09/2020. In the Tuition fee guide 2020/2021 Politecnico will publish updated rules and costs for sessions scheduled after 1st October 2020.

5. You **can** take the IELTS exam at the CLA one time free of charge if:

a) you are enrolled in a **Bachelor's degree programme** (DM 270/04 or 509/99) at Politecnico di Torino and the **English language exam is one of your curricular requirements**;
b) you are enrolled in a **Laurea Specialistica** (DM 509/99) at Politecnico di Torino and the **English language exam is one of your curricular requirements**, provided that you have not already taken the IELTS exam free of charge one time and you have not received any IELTS fee refund during previous university paths.

6. You **cannot** take the IELTS exam at the CLA free of charge if:

- c) you are enrolled in a **Master's degree programme** (DM 270/04) at Politecnico di Torino;
- d) you already earned the English language exam credits because you presented an English language certificate to Politecnico di Torino.

The following rules apply if you have the right to take the exam free of charge.

7. If you register for the IELTS exam, but you do not take all the exam modules:

- d. if you cancel registration for the IELTS exam before the deadline of the Terms and Conditions (accepted during the registration process), you will not be charged the IELTS fee and you will be able to register again for a new exam session free of charge.

 - d. if you cancel your registration for the IELTS exam before the deadline of the Terms and Conditions (accepted during the registration process), the IELTS fee will be refunded to you.
 - e. if you justify your absence with the necessary documents before the deadline of the Terms and Conditions (accepted during the registration process), the IELTS fee will be refunded to you.

Article 59. PLIDA (Italian language exam) payment policy

1. The PLIDA exam (Progetto Lingua Italiana Dante Alighieri) for Politecnico students is organized by the University Language Centre (CLA) in cooperation with Società Dante Alighieri. The Academic Senate of Politecnico adopted the PLIDA certificate as the language certificate required to demonstrate knowledge of the Italian language.
2. You can take the PLIDA exam one time free of charge at the CLA if you are enrolled in a Bachelor's or Master's degree programme for which the knowledge of the Italian language is a graduation requirement.
3. The PLIDA exam is composed of 4 tests (each test is designed to assess a language ability).
The PLIDA fees are:
 - a) A2 level - full exam: € 90.00
 - b) B1 level - full exam: € 100.00
 - c) Registration fee for a single test: € 15.00 for A2 level; € 20.00 for B1 level (registration for a single test is possible only if you need to make up for an unpassed test of a PLIDA exam taken at Politecnico).
4. The following rules apply if you have the right to take your first PLIDA exam free of charge but you are absent on the day of the exam:
 - a) Absence from all tests
 1. If you provide a medical certificate, you will not be charged the PLIDA fee and you will be able to register again for a new PLIDA session free of charge. The medical certificate must be presented to Società Dante Alighieri within five working days of the written test and must certify that you were unable to sit the exam.
 2. If you do not justify your absence with the necessary documents, you will be charged the PLIDA fee in full, but you will be able to register again for a new PLIDA session free of charge.
 - b) Absence from one or more tests
 1. If you provide a medical certificate, you will not be charged the PLIDA fee. You will be able to register again for the tests you missed free of charge within the next 18 months. The medical certificate must be presented to Società Dante Alighieri within five working days of the test date and must certify that you were unable to sit the exam.
 2. If you do not justify your absence with the necessary documents, you will be charged the PLIDA fee in full. You will be able to register again for the tests you missed within the next 18 months. You will have to pay for these tests.
5. The following rules apply if you do not have the right to take the PLIDA exam free of charge.
If you register for the PLIDA exam but you are absent on the day of the exam:

- a) Absence from all tests
 - 1. The PLIDA fee will be refunded to you in full if you present a medical certificate to Società Dante Alighieri within five working days of the written test. The certificate must certify that you were unable to sit the exam.
 - 2. The PLIDA fee will NOT be refunded to you if you do not justify your absence with the necessary documents.
- b) Absence from one or more tests
 - 1. If you provide a medical certificate, you will be reimbursed only for the cost of the tests for which you presented the certificate. The medical certificate must be presented to Società Dante Alighieri within five working days of the test and must certify that you were unable to sit the exam. You will be able to register again for the tests you missed within the next 18 months. You will have to pay for these tests.
 - 2. If you do not justify your absence with the necessary documents, the PLIDA fee will NOT be refunded to you. You will be able to register again for the tests you missed within the next 18 months. You will have to pay for these tests.
- 6. If the Italian language exam is not a curricular requirement of your degree programme, you must pay the PLIDA fee through your student virtual account when you register for the PLIDA exam. If you are absent from the exam but you do not justify your absence, you will have to pay the PLIDA fee within 30 days of the payment due date. If you do meet this deadline, a hold will be placed on your academic progress and you will not be able to perform any further operations (such as exams, withdrawal from studies, etc.).

For refunds, reference is made to Articles 23 and 24.
